General information

Move victim out of danger zone and lay down. Position and transport victim on their side. In case of respiratory distress, bring into semi-upright, seated position. Self-protection of the first aider.. Change contaminated clothing. Do not put any product-impregnated cleaning rags into your trouser pockets.

After inhalation


